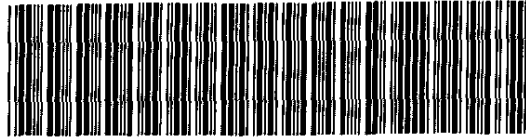

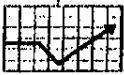

The name of the Limited Liability Company shall be LOGI GROUP, LLC


