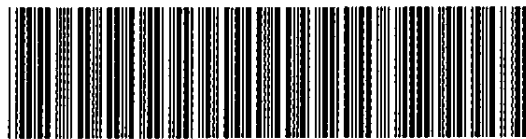

lawful business, including the family management of family interests, within or without the State of Florida.

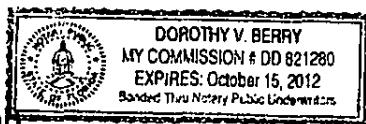


