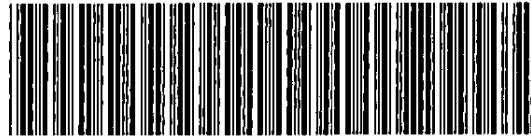

Principal Office**

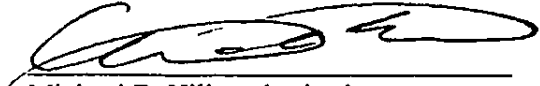

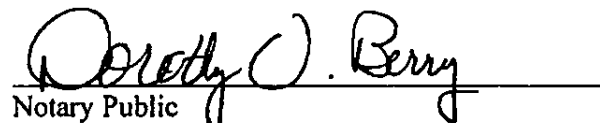
