ARTICLES OF ORGANIZATION OF

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said Limited Liability Company shall be, PAMPA ZULU, LLC and the mailing address and the street address of the principal office of the limited liability company shall be 2750 NE 183 St # 211 Aventura FL 33160 and the street address of the principal office of the limited liability company shall be: 2750 NE 183 Street # 211 Aventura, FL 33160

SECOND: PAMPA ZULU, LLC, LLC shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which, PAMPA ZULU, LLC is formed are:

FIFTH: This limited liability company shall be member-managed and it will have TWO managing member: MARIANO CARLOS LOZANO at 2750 NE 183 Street






