
ARTICLE IV. MANAGEMENT OF COMPANY

This Company shall indemnify any officer, director, employee, or agent, and any former officer, director, employee, or agent, to the full extent permitted by law.



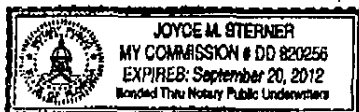
ACCEPTANCE BY REGISTERED AGENT


