**ARTICLES OF ORGANIZATION OF  
D-Y HARD FAN, LLC**

The undersigned authorized representative of the member pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby submits the following Articles of Organization:

**ARTICLE I. NAME** - The name of the limited liability company shall be D-Y Hard Fan, LLC (the "Company").

**ARTICLE II. MANAGEMENT** - The initial managers of the Company are James A. Turner, III and Ann S. Turner.
