ARTICLES OF ORGANIZATION OF PROPERTY POWER INVESTMENTS, LLC

The undersigned member(s), or authorized representative of a member, for the purpose of forming a Limited Liability Company pursuant to Chapter 608, Florida Statutes, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company shall be: Property Power Investments, LLC

ARTICLE II - ADDRESS

The principal place of business of this Limited Liability shall be: 6005 Stirling Road, Suite 173, Davie, Florida 33314.

ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

ARTICLE IV - DURATION

The Limited Liability Company shall exist in perpetuity.

ARTICLE V - MANAGEMENT

ARTICLE VI – ADMISSION OF ADDITIONAL MEMBERS

The members of the Limited Liability Company shall have the right to admit additional members upon a majority vote of the existing members in accordance with Article XI, governing voting, contained herein.

ARTICLE VII - MEMBERSHIP AND MEMBERSHIP INTERESTS OF MEMBERS

In an event, no distribution may be made if, after the distribution, the Limited Liability Company would not be able to pay its debts as they came due in the usual course of business, or if the Limited Liability Company's total assets would be less than the sum of its total liabilities, excluding liabilities to members on account of their capital contributions.

ARTICLE X – SHARING OF PROFITS AND LOSSES

Sharing of profits and losses shall be allocated on the basis of each member's membership interest in the Limited Liability Company.

ARTICLE XI – VOTING

Members of the Limited Liability Company are entitled to vote on matters concerning the Limited Liability Company and each member's vote shall be weighted in accordance with each member's membership interest in the Limited Liability Company.

ARTICLE XII – WITHDRAWAL OF A MEMBER

The remaining members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company provided that the remaining embers operate the business of the Limited Liability Company in full compliance with these Articles of Organization , the regulations of the Limited Liability Company and all applicable local, state, and federal laws.
