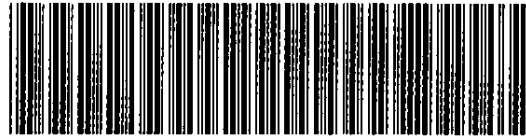



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I – NAME**

The name of the limited liability company shall be MUSICBOX MINISTRIES, L.L.C. (hereafter “Company”).

**ARTICLE II – PRINCIPAL OFFICE**

**ARTICLE V – REGISTERED OFFICE AND AGENT**



**ARTICLE VI – MANAGEMENT**


