As of 6/1/2021 the owner/operator and contact information for TES NOTARY LLC with the IRS for FEIN remains Tonya Sellers; nothing has been filed with the IRS by Chris Holmes to update the contact name and address or any other required information to show Chris as the new owner/operator of TES NOTARY LLC.
- (C) Unknown person created a unauthorized website for TES NOTARY LLC without my knowledge or consent under the web address https://tesnotaryllc.com with a Russian registrar, reg.ru llc, in 2/2021. The website states it does business as a Florida real estate investment and management solution and it lists the contact address as the Miami address documented above in 3(A) with a contact email address of info@tesnotaryllc.com. I, Tonya Sellers did not create or authorize this website nor am I the owner of it.
