

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Manager desires to amend and restate the Articles of Organization of Margin Free, LLC, a Florida a limited liability company by delivering these Amended and Restated Articles of Organization in duplicate to the Department of State of the State of Florida, in accordance with Florida Revised Limited Liability Company Act (the Act). These Amended and Restated Articles of Organization were approved by the Members of Margin Free, LLC.

SECTION 2 NAME

The name of the limited liability company is Margin Free, LLC, a Florida limited liability company (**Company**).

SECTION 3 DURATION

The Company will perpetually exist from the filing date of these Articles of Organization with the Department of State of the State of Florida, unless dissolved according to law.

SECTION 8 ADDITIONAL MEMBERS

This Operating Agreement may be amended from time to time according to its provisions.

SECTION 11 MANAGEMENT
