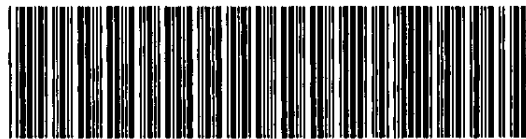

The undersigned certifies that LW & JW, LLC was organized for the purpose of becoming a limited liability company under the laws of the State of Florida on September 21, 2011, providing for the formation, rights, privileges, and immunities of limited liability companies. The undersigned hereby amends and restates the Articles of Organization of LW & JW, LLC as follows:

ARTICLE I

(Name and Principal Place of Business)

The name of the limited liability company is LW & JW, LLC and the mailing address of its principal office is 5089 Highway A1A, Suite 100, Vero Beach, Florida 32963.

ARTICLE II

(Period of Duration)

The limited liability company came into existence upon the filing of Articles of Organization with the Secretary of State, State of Florida, on September 21, 2011. The limited liability company shall continue to have perpetual existence, unless earlier terminated by operation of law or as provided in these Articles or the Operating Agreement of the limited liability company.

ARTICLE III

(Registered Office and Registered Agent)

ARTICLE IV

ARTICLE V
(Right to Continue Business)

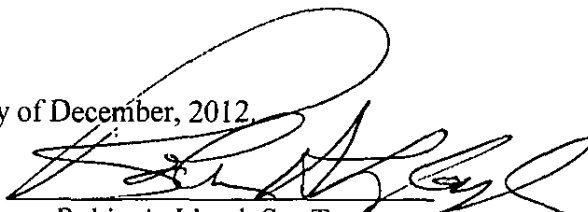
