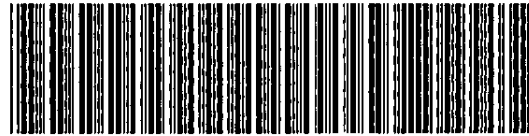

ARTICLE FOUR - Management:


