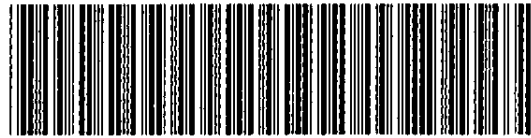

ARTICLES OF ORGANIZATION
OF
FUP V, P.L.

The undersigned hereby certifies that he is the Authorized Representative of a Member who is forming a Professional Limited Liability Company under Chapter 621, Florida Statutes. The following Articles of Organization are hereby adopted.

ARTICLE I.
NAME

The name of the Professional Limited Liability Company shall be FUP V, P.L.

ARTICLE II.
DURATION; EFFECTIVE DATE

This Professional Limited Liability Company shall exist perpetually commencing as of September 16, 2011.

ARTICLE III.
ADDRESS; PRINCIPAL OFFICE

The mailing address of the Professional Limited Liability Company and the street address of the principal office of the Limited Liability Company is 4700 North Habana Avenue, Suite 600, Tampa, Florida 33614.

ARTICLE IV.
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the Professional Limited Liability Company is 150 2nd Avenue North, Suite 1100, St. Petersburg, Florida 33701 and the name of its initial registered agent at such address is Joel D. Bronstein.

ARTICLE V.
PURPOSE

This Professional Limited Liability Company is organized for the purpose of owning a partnership interest in Florida Urology Partners, LLP, a Florida limited liability partnership and to operate a group medical practice through Florida Urology Partners, LLP along with such other activity or business permitted under the laws of the United States of America and of this State as the Members may determine.
