ARTICLE V

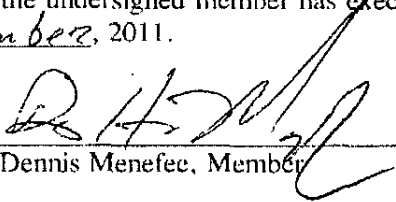

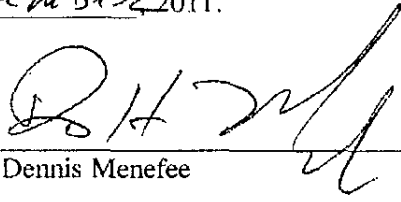
