ARTICLES OF ORGANIZATION OF IDEAL INVESTMENTS, LLC

- 1. Name. The name of this limited liability company is IDEAL INVESTMENTS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. <u>Duration.</u> The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- 3. <u>Purpose.</u> The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
- 4. <u>Place of Principal Office.</u> The mailing and street address of the Company's principal office is 2637 26th Ave. N., Apt. 4, St. Petersburg, Florida 33713.
- 5. Registered Agent and Office. The name of the initial registered agent of the Company is Spoor Law, P.A. The street address of the initial registered agent of the Company is 111 2nd Avenue NE, Suite 1600, St. Petersburg, FL 33701.
- 6. <u>Management of the Company</u>. The management of the Company shall be vested in the members of the Company. The initial member of the Company is Fred Howard Swing, III,
- 7. Operating Agreement. The members shall have the power to adopt, after, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
- 8. Additional Members. Additional members to the Company may be admitted, but only upon the consent of all of the other members of the Company at the time admission is sought, or as may otherwise be permitted under the Company's Operating Agreement.
