**ARTICLES OF ORGANIZATION  
OF

1. Name. The name of this limited liability company is **IDEAL INVESTMENTS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

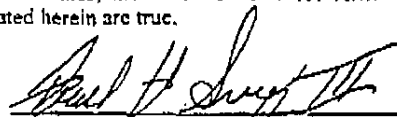
6. Management of the Company. The management of the Company shall be vested in the members of the Company. The initial member of the Company is **Fred Howard Swing, III.**
