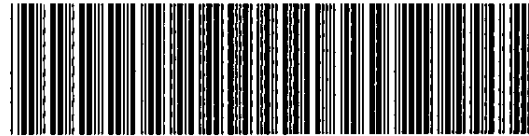


These Articles of Organization, and theretofore the company, shall be effective immediately upon the approval of the Florida Department of State, Division of Corporations.
