**ARTICLES OF ORGANIZATION FOR  
FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned does hereby present these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapter 621, Florida Statutes.

**ARTICLE I - Name**

The name of the Professional Limited Liability Company is Levin Papantonio International, PLLC.

**ARTICLE II - Addresses**

The mailing address and street address of the principal office of the Professional Limited Liability Company are:

**ARTICLE III - Duration**

The period of duration of the Professional Limited Liability Company shall be perpetual.

**ARTICLE IV - Purpose and Powers**

Furthermore, each of the individual shareholders of a professional corporation that is a member of the Professional Limited Liability Company must be licensed to practice law, and each of the individual members of a professional limited liability company that is a member of the Professional Limited Liability Company must be licensed to practice law.

A member's interest in the Professional Limited Liability Company may not be sold or otherwise transferred except to a transferee authorized to be a member pursuant to this Article V and otherwise in accordance with the Operating Agreement of the Professional Limited Liability Company.

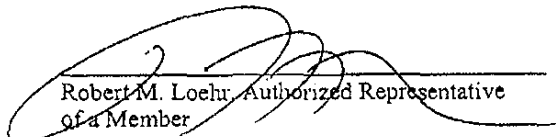

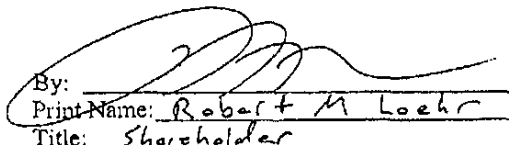
