**ARTICLES OF ORGANIZATION
OF
PURO CHILE MIAMI LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Puro Chile Miami LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 7095 SW 47th Street, Miami, Florida 33155.

ARTICLE III. REGISTERED AGENT AND OFFICE

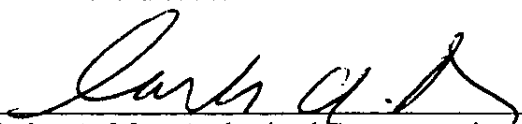
ARTICLE IV. DURATION
