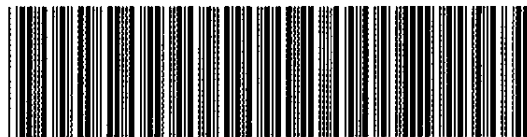

Pursuant to Section 608.407 of the Florida Limited Liability Company Act, the undersigned, as the authorized representative of a member of A Day in the Life Investments, , LLC, does hereby make, subscribe, acknowledge and file these Articles of Organization for the purpose of becoming a Limited Liability Company under the Laws of the State of Florida.

ARTICLE I. NAME

MANAGEMENT. The Limited Liability Company shall be a member-managed Limited Liability Company. The members of the Limited Liability Company may elect or appoint one or


