The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

ARTICLE 2 - ADDRESS

ARTICLE 4 - DURATION

ARTICLE 5 - PURPOSES AND POWERS

The general purpose for which the Company is organized is to engage in the business of horse training and selling and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. 


