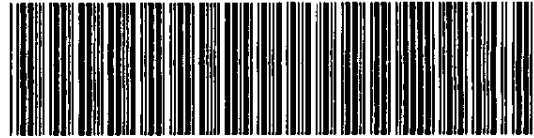

The Partners will also execute a General Transfer of all Interest, Assets, Liabilities and Obligations to the LLC. The LLC will acknowledge receipt of such.



