ARTICLES OF ORGANIZATION OF SPECIALIZED BUILDING MATERIALS, LLC,

a Florida Limited Liability Company

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

ARTICLE I NAME

The name of the limited liability company is SPECIALIZED BUILDING MATERIALS, LLC, a Florida limited liability company (the "Company").

ARTICLE VI DURATION

The Company's duration shall be perpetual.
