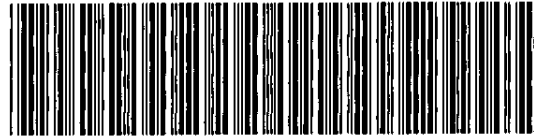

No Pending Suits




