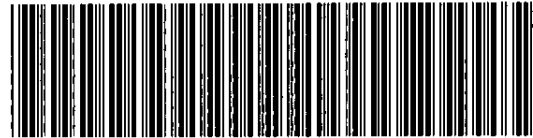




ARTICLE 6


