LETTERS OF CURATORSHIP

TO ALL WHOM IT MAY CONCERN

WHEREAS, Yehezkel Cohen, a resident of Hillsborough County, Florida, died on August 10, 2013, owning assets in the State of Florida, and

WHEREAS, Steven L. Hearn has been appointed Curator of the estate of the decedent and has performed all acts prerequisite to issuance of Letters of Curatorship in the estate,

NOW, THEREFORE, I, the undersigned circuit judge, declare Steven L. Hearn duly qualified under the laws of the State of Florida to act as Curator of the estate of Yehezkel Cohen, deceased, with full power to administer the estate according to law, including the authority to take the following actions:

- 1. To marshal, preserve and protect the assets of the estate, and take all reasonable actions necessary to preserve and protect the assets of the estate (including but only upon obtaining prior court approval, the authority to issue subpoenas, file lawsuits to collect assets, and to litigate disputes concerning title of estate assets);
- To proceed with the notification of creditors of the estate as provided by the Florida Probate Code, including, but not limited to, publishing notice to creditors;
- 3. To pay, object to, and/or defend the validity of creditor claims;
- 4. To defend any actions brought against the estate;
- 5. To prepare and file all tax returns required of the Decedent and the estate, and to pay such taxes;
- 6. To petition the court to determine intestate heirs; and
- 7. To employ persons, including, but not limited to, attorneys, accountants, auditors, appraisers, and others reasonably necessary to advise or assist the Curator in

performance of its administrative duties, to act upon the reasonable recommendations of those employed without independent investigation, and, instead of acting personally, to employ one or more agents to perform any act of administration, whether or not discretionary.

Notwithstanding the foregoing, the Curator is specifically <u>prohibited</u> from making distributions to any named beneficiary of the estate or filing any lawsuit without the prior written approval of this Court.
