**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
ISLAND LIFE GROUP, LLC**

WHEREAS, the name of the company is Island Life Group, LLC, a Florida limited liability company (the "Company");

WHEREAS, the Company was formed pursuant to the laws of the State of Florida on October 7, 2011 by the filing of Articles of Organization and assigned Document Number L11000115651; and

WHEREAS, the Company and its members, by and through the undersigned authorized representative and pursuant to the provisions of Section 608.411 of the Florida Statutes, desire to amend the Articles of Organization in the manner set forth below;

NOW, THEREFORE, the Company amends its Articles of Organization as follows:

1. Article IV of the Articles of Organization of the Company is hereby deleted in its entirety and the following Article IV is inserted in its place:

"ARTICLE IV – Management

The limited liability company is to be managed by a manager or managers and is, therefore, a manger-managed company. The initial managers of the limited liability company shall be Michael Wiles and Andre Forde."

2. The date of adoption of the foregoing amendment to the Article of Organization is October 21, 2011.

3. Except as specifically amended hereby, the Articles of Organization of the Company shall remain in full force and effect.
