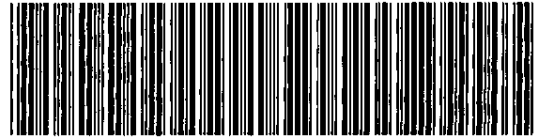

a Florida Limited Liability Company (FS 608.407)*

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such Company:

ARTICLE I – NAME


ARTICLE VIII - INDEMNIFICATION


