ARTICLES OF ORGANIZATION OF <u>5 POINT HUNT CLUB, LLC</u>

ARTICLE I - NAME

The name of this Limited Liability Company is 5 POINT HUNT CLUB, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS
