AMENDED AND RESTATED ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of a member, desiring to amend and restate the articles of organization of this limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Amended and Restated Articles of Organization:

ARTICLE I. NAME / FILING DATE

The name of the limited liability company is **AMERICAN CONNECT SERVICES LLC** (the "Company"). The Articles of Organization of the Company were filed on October 17, 2011 with an effective date of October 12, 2011, and assigned document number L11000119059.
