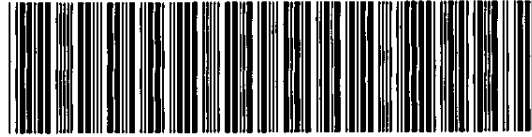

The name of the Limited Liability Company is FOB Holdings, LLC (the "Company").

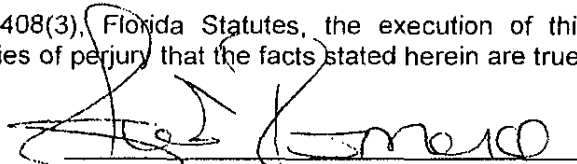
