**AMENDED AND RESTATED ARTICLES OF ORGANIZATION  
OF  
YALE MORTGAGE FUNDING, LLC**

These Amended and Restated Articles of Organization for Yale Mortgage Funding, LLC are being filed pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act and hereby amend, in their entirety, the Articles of Organization filed with the Florida Secretary of State on October 19, 2011 under Document Number L11000119690.

**ARTICLE I - Name**
