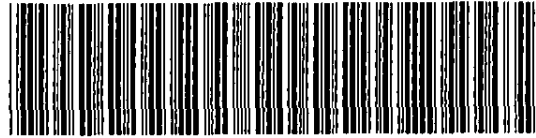

The mailing address and street address of the principal office of the Company is: 136 Island Creek Drive, Vero Beach, Florida 32963.






