ADMISSION OF NEW MEMBERS

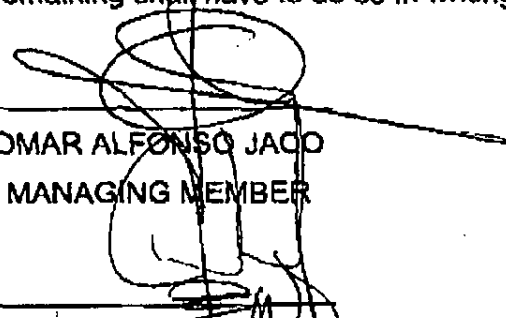

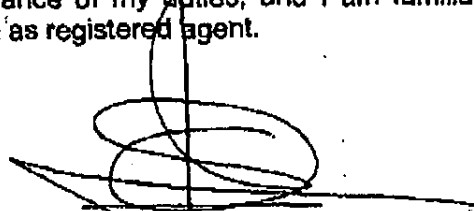
