The undersigned person, acting as the organizer of SOUTHERN KEYS, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

SOUTHERN KEYS, LLC

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on the date these Articles of Organization are filed with the Florida Department of State, and the existence of the company shall be perpetual.

ARTICLE III - PURPOSE

The company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.

ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office of the company is 1819 Main Street, Suite 610, Sarasota, FL 34236, and the name of the company's initial registered agent at that address is JOHN M. COMPTON.

ARTICLE V - PLACE OF BUSINESS

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The right of the members to admit additional members and the terms and conditions of the admissions shall be restricted solely to those members approved by the written consent of all of the then-existing members and upon such terms and conditions as shall be set forth in its operating agreement.

ARTICLE VII - MANAGEMENT BY MANAGER

The company shall be managed by one or more managers upon such terms and conditions as shall be set forth in its operating agreement. The initial manager of the Company shall be Stanley J. Sabuk, and his mailing address shall be 6150 State Road 70 East, Bradenton, Florida 34203.

ARTICLE VIII - REGULATIONS

The power to adopt, alter, amend or repeal the rules and regulations of the company in the form of an operating agreement or otherwise is vested exclusively in the members of the company.
