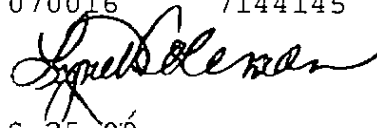

- FIRST:** The name of the limited liability company filing these Amended and Restated Articles of Organization is Research Centers of America, LLC (the "Company").
- SECOND:** The Articles of Organization of the Company were filed with the Corporation Division of the Florida Department of State on October 27, 2011 and assigned document number L11000122821.

- FIFTH:** These Amended and Restated Articles of Organization are submitted to amend and restate the Articles of Organization of the Company in its entirety to read as follows:

ARTICLE I

NAME
