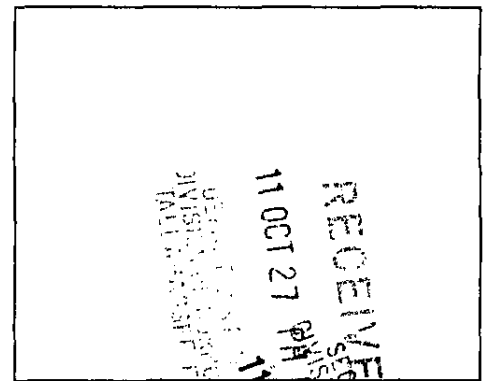

NAME

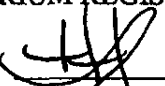
