**ARTICLES OF ORGANIZATION
OF
EZ1 MANAGER, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is EZ1 Manager, LLC, LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS


ARTICLE IV. DURATION

IN WITNESS WHEREOF, the undersigned has made and subscribed to these Articles of Organization on October 28, 2011.


