**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
CEDAR TREE GROUP LLC  
(a Florida limited liability company)**

The undersigned, in amending and restating the Articles of Organization of a Florida limited liability company under the Florida Revised Limited Liability Company Act (Chapter 605 of the Florida Statutes, § 605.0101 *et seq.*; the "Florida Act"), hereby adopts the following Amended and Restated Articles of Organization:

1. **Name.** The name of the limited liability company is CEDAR TREE GROUP LLC (the "Company"), and the Document Number assigned to the Company by the Florida Department of State, Division of Corporations is L11000123755.

2. **Filing of Articles of Organization; Effect of Amended and Restated Articles of Organization.** The Articles of Organization of the Company (the "Original Articles") were filed on October 31, 2011. These Amended and Restated Articles of Organization of the Company shall amend and restate the Original Articles in the entirety.

5. **Management.** The Company shall be managed by one or more managers as a manager-managed limited liability company under the Florida Act.


6. **Manager.** As of the date of execution hereof, William Shaheen is the manager of the Company.


8. Effectiveness. These Amended and Restated Articles of Organization shall be effective as of the date registered by the Florida Department of State, Division of Corporations.
