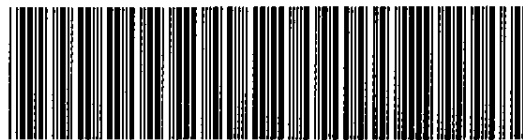

**ARTICLES OF ORGANIZATION OF

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "KRISHON'S FRESH CARPET OF OCALA, LLC."

ARTICLE II - Address

ARTICLE V - Management

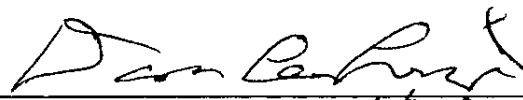
The Company is to be managed by the members.
