**ARTICLES OF AMENDMENT
OF ARTICLES OF ORGANIZATION OF
LEAN LOCAL, L.L.C**

Pursuant to the provisions of Florida Statute 608.411 of the Florida Limited Liability Act, the undersigned Company adopts the following Articles of Amendment of its Articles of Organization:

- FIRST: The name of the limited liability company is: Lean Local, L.L.C.
- SECOND: The date of filing of the Articles of Organization was: November 2, 2011.
- THIRD: The Articles of Organization of Lean Local, L.L.C. are hereby amended as follows:

ARTICLE VII – MANAGEMENT

The management of the Limited Liability Company shall be by the Members.
