**ARTICLES OF ORGANIZATION
OF
SPB JVCO, LLC**

1. Name. The name of this limited liability company is **SPB JVCO, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist effective as of November 1, 2011 and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing address for the Company is Post Office Box 1839, Tampa, Florida 33601. The street address of the Company's principal office is 507 South 58 Street, Tampa, Florida 33619.

6. Management of the Company. The management of the Company shall be vested in the managers of the Company.

7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
