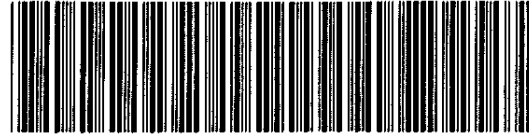

OF



Neither the amendment nor the repeal of this Article shall eliminate or reduce the effect of this Article in respect to any matter occurring, or any cause of action, suit or claim that, but for this Article, would accrue or arise, prior to such amendment or repeal. This Article shall neither eliminate nor limit the liability of a manager for any act or omission occurring prior to the adoption of this Article.
