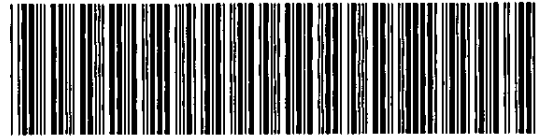

**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

The name of the limited liability company is IL VILLAGGIO 205, LLC (hereinafter called the "Company")."


"ARTICLE II - ADDRESS
