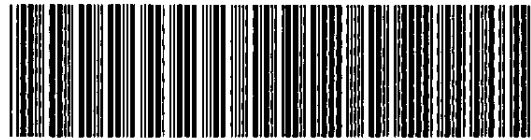


Article VII - Operating Agreement


