The Articles of Organization for RIT Nashville, LLC were filed on November 3, 2011 and assigned Florida document number L11000125627.

This Amendment is submitted to amend the following:

First: Article VI - An additional Article VI, Liability of Members, shall be added. The Articles of Organization are hereby amended to add an Article VI after the existing Article V to state the following:

**"ARTICLE VI
LIABILITY OF MEMBERS**

For purposes of any activities of the Company in the State of Tennessee, the Company hereby elects, that pursuant to Sections 48-249-114(f), Section 67-4-2008(a)(9) and Section 67-4-2008(d) of the Tennessee Code Annotated, each Member of the Company hereby waives all limited liability with respect to the Company and agrees to be personally liable for all debt, obligations and liabilities of the Company (arising from Contract, tort or other) to the same extent as a general partner of a general partnership. Prior to being admitted as a Member of the Company, and any all future Members must agree to assume joint and several personal liability for all debts, obligations and liabilities of the Company and sign an amendment to the Articles of Organization of the Company assuming such liability relative to any activities of the Company in the State of Tennessee. In the event that an amendment is made to the Articles of Organization of the Company striking the joint and several liability of any one (1) Member, then such amendment shall strike the joint and several personal liability of all Members."
