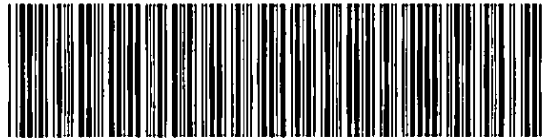

Pursuant to Section 605.0207 of the Business Corporation Act of the State of Florida, the undersigned, being the Manager of ECCENTRIQ DEVELOPMENT SOLUTIONS LLC, (hereinafter the "Limited Liability Corporation"), a Florida corporation, and desiring to amend and restate its Articles of Organization, does hereby certify:

FIRST: Articles of Organization of the Corporation were filed with the Secretary of State of Florida on November 04, 2011, Document No. L11000125825.

SECOND: Amended and restated articles of incorporation were adopted by all of the members pursuant to sections 605.0207 of the Florida Business Corporation Act on September 4, 2018. The number of votes cast for the amendment to the Corporation's Articles of Organization was sufficient for approval.

PURPOSE**

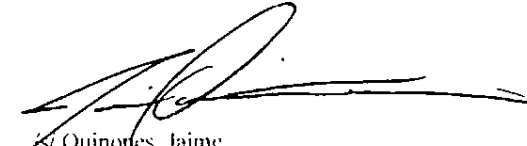
The Limited Liability company is organized and may transact any and all lawful business for which corporations may be organized under the Florida Business Corporation Act.

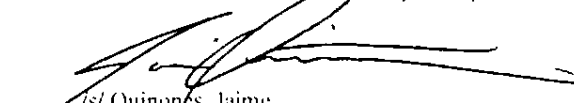
