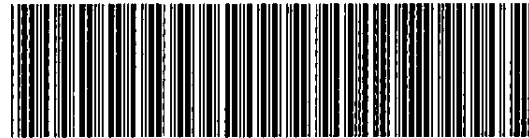

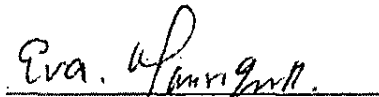

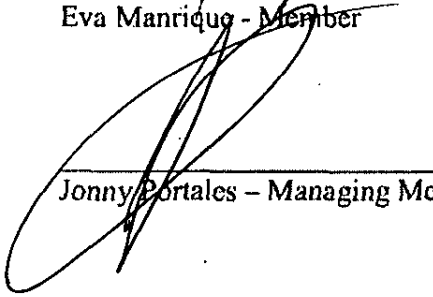
Articles Of Organization of

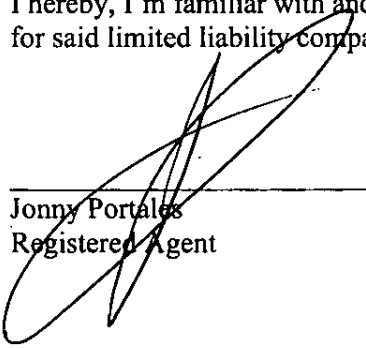
