# ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

#### ARTICLE I

#### Name


The name of the limited liability company created hereby (hereinafter, "the Company") is: SRM ROBSON PROPERTIES, LLC
