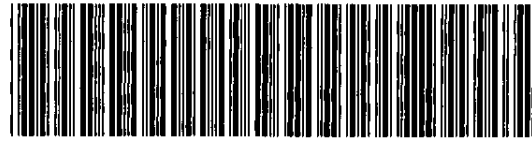

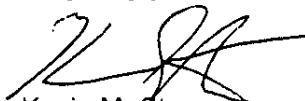

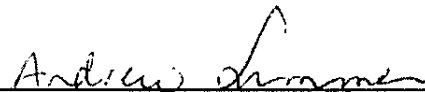

RESOLVED, that the Company desires to change its name to BISHOPS GATE PROPERTY COMPANY, LLC to be effective immediately.

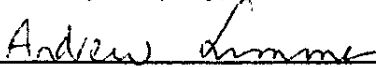
